# The Modular Training Program

- Experiential Workshops: acknowledged if conducted by certified DMT. At least 50% by certified Dmt-ER® (see the map on <a href="https://www.danzaterapia-esprel.it/chi-siamo">https://www.danzaterapia-esprel.it/chi-siamo</a>)
- **Training Activities:** 
  - ⇒ Mandatory Online Seminars, on Thursdays 5-9 PM and Fridays 10 AM-2 PM, C.E.T. (13-14 February, 3-4 April, 25-26 September, 11-12 December)
  - ⇒ Intensive Training Workshops, on choice, in Egypt (24-28 June, 11-15 November) and Italy (see the red marked activities on <a href="https://www.danzaterapia-esprel.it/appuntamenti">https://www.danzaterapia-esprel.it/appuntamenti</a>)
- Field Experiences: in your country, with different populations and institutions, after planning them in supervision. They can include active observation and conduction.
- Supervision:
  - ⇒ Mandatory Online Group sessions, on Fridays 10 AM-2 PM, C.E.T. (14 March, 18 April, 5 September, 17 October)
  - ⇒ Supervision onsite days, on choice, in Egypt (29 June, 16 November), or in Italy
  - ⇒ Individual online supervision (1 included in the basic fee)
- Interdisciplinary elements (Psychology, Psychopathology, Anatomy): personal study, (topics in the private area of the website). Pre-exam online seminar on demand.
